

NEW MARKETS LAB AGRICULTURAL LAW RESEARCH FELLOWSHIP

The New Markets Lab (NML) – a law and development innovation lab dedicated to generating and disseminating data-driven research, tools, and approaches focused on equitable and inclusive design and implementation of economic law and regulation – has established a new Agricultural Law Fellowship Program. NML is seeking applications for a research fellow to work under its Agricultural Law Program on substantive matters related to agricultural law and regulation, NML's Digital Regulatory Lab, and other initiatives and partnerships. The fellowship would focus on conducting legal research and writing with regard to national and regional agricultural regulation (including regulation of seed, fertilizer, etc.), intellectual property rights (with a specific focus on enhancing farmers rights), licensing, and other related issues in the context of agricultural rules, such as climate change, environment, gender, etc. This research will be in line with NML's mission to leverage law and regulation as a tool for sustainable and inclusive economic development.

This fellowship will be part of NML's Legal Fellowship Program, which is intended to support the development of substantive legal and regulatory knowledge across disciplines, with a focus on how economic legal and regulatory systems are both designed and implemented in practice. Consistent with NML's work as an international non-profit center for law and development, the Legal Fellowship Program helps fellows expand their understanding of legal and regulatory requirements within national, regional, and international systems and the interaction between these different areas of law and economic and social development considerations.

Requirements

Applicants should hold at least have a Bachelor's Degree in Law and have demonstrated skills and experience in legal research and writing. A Master's Degree in Law is preferred but not required. Applications must include a CV, writing sample, and at least one letter of reference that speaks to the applicant's research and writing skills. Previous experience or background in agricultural law, regulation, and policy would be preferred. The position also requires proficiency English. Applicants must be motivated and capable of reliably implementing work projects in a distance working arrangement. This position will require a commitment of at least 30-40 hours a week, with flexibility given for holidays. The Agricultural Law Research Fellowship includes a fellowship stipend of USD \$5000.
